Regarding the change in program participation and how it impacted our total homeless and particularly our sheltered count, we discovered that there were three projects (Care Tallahassee, Good Samaritan Network and Chelsea's House) that do not exclusively serve homeless individuals any longer which accounted for approximately 60 individuals on the 2019 count. Care Tallahassee and Good Samaritan Network both serve men exiting prison and therefore the population does not count as homeless under the HUD definition due to them being in prison longer than 90 days. These 3 programs did not confirm they had any cases on the night of 1/27/20 that would meet the homeless definition for the HUD PIT count. The problem we discovered is that because these programs do not exclusively serve homeless individuals, the inclusion of all or part of their census count in 2019 was inappropriate. In 2020, we corrected this issue by requiring the programs to identify specific numbers of persons who met the definition for the HUD PIT count. This correction had a substantial impact on the difference between our 2019 and 2020 total and sheltered count.

The 2019 PIT count was 91, compared to 109 in 2020 for an increase of 18 people. During the time of PIT count, our transitional living program for youth (CCYS TLP) being phased out due to a loss of federal funding. Only one youth was at the TLP the night of the PIT. Youth who would typically be TLP residents fell into the unsheltered category this year. Also, a long-term permanent housing project (Mission Oaks) that previously exclusively served men exiting homelessness was taken on by new management and their focus is towards low-income persons who were not previously homeless. This change, though made a couple of years ago, is now contributing to our CoC's increase in unsheltered homeless. Moreover, our count was more comprehensive than ever before. We included better coverage of our CoC\'s geographical area and fully surveyed one of our eight counties for the very first time, Jefferson County, making this the most comprehensive PIT in our CoC\'s history. By being more comprehensive, we identified more unsheltered individuals.
