Home Plate Combined is a housing first modeled, scattered-site, leasing project providing permanent supportive housing for 70 single individuals exiting chronic homelessness. All apartments leased are accessible by public transportation. Housing and supportive services needs are assessed pre-referral, post-referral, and then ongoing. Needs are met by linking the participant to landlords, mainstream benefit service providers, faith-based groups, and other community members. The project provides a Housing Specialist and 1.5 full-time Case Managers. Case Managers offer and coordinate supportive services based on the participants' needs and interests. This combined project will increase the number, expand the variety, increase the frequency, and increase the intensity of supportive services and increase contact from quarterly to monthly and to daily/weekly for high-risk participants. First, it will add .5 FTE Case Manager to help reduce the existing caseload.

Other increases will be: more SOAR certified staff time assisting individuals with SSDI/SSI applications. More time assisting individuals with Vocational Rehabilitation and attempting to secure supports from faith-based organizations. More time educating individuals about how to independently access Big Bend 2-1-1 and be more self-sufficient. More time connecting individuals with covered healthcare services and educating them about those services. More time connecting individuals with a wider variety of mental health, counseling, and substance abuse resources. More time connecting individuals with felony convictions with life skills training resources.

The project will dedicate new supportive services funding to meet specific participants needs: \$2000 to assist with transportation needs that exceed available resources. \$500 dollars to assist with emergency food needs that exceed current resources. \$500 dollars to assist with outpatient health services costs. \$3000 dollars to assist with moving costs. The project will also continue to provide \$5250 to cover the utilities of participants with no income. The project provides supervision for the Case Managers and for the Housing Specialist.

The anticipated project outcome(s) are that no more than 10% of participants will return to homelessness, 8% of participants will experience new or increased earned income and 10% of participants will experience new or increased nonemployment income, and at least 90% of program participants will remain in or move into permanent housing. The project will coordinate extensively with other organizations to ensure linkages to employment & income support services, emergency assistance, transportation assistance, healthcare/benefits, education, and other services. CoC Funding is required to lease the one-bedroom units for program participants in scattered site apartments in Tallahassee and Leon County and partially fund the staffing required for the program to be successful.



- Housing Navigation. Grant funds can be used to pay staff time necessary to identify safe units and facilitate moves into housing for survivors through emergency transfer(s).

- Technology to make an available unit safe. Grant funds can be used to pay for technology that the individual believes is needed to make the unit safe, including but not limited to doorbell cameras, security systems, phone, and internet service when necessary to support security systems for the unit, etc.
